C. Graham Carothers Award of Excellence

The C. For thirty-five years, Graham Carothers truly served as “the school board lawyer’s lawyer” giving countless hours of his time for public education in Florida.

A plaque is presented to each recipient of the C. Graham Carothers Award of Excellence.
