Graham greeted your telephone call with “Hello, Lawyer, what can I do for you?” He always had time to assist. Ninety-nine times out of one hundred, Graham knew the answer off the top of his head, citing the appropriate case or statute and, oftentimes, directing the lawyer to the specific spot on the page where the answer could be found. For thirty-five years, Graham

Carothers truly served as “the school board lawyer’s lawyer” giving countless hours of his time for public education in Florida.
